Instructions regarding cases registered on National Cyber Crime Reporting Portal (NCRP)(<u>www.cybercrime.gov.in</u>), MHA, Govt. of India.

Sir/Madam,

It has come to the notice that 30-40 complaints against cyber frauds are registered daily in Cyber Crime Police Stations in H.P. Investigation Officer register the complaints on the National Cyber Reporting Portal, follow the trail money, siphoned off in these complaints and get it blocked/ put on hold u/s 102 Cr.PC, later to be released by the trial Courts u/s 457 Cr.P.C. However when complainant approaches the trial Courts for the release of said funds with relevant bank details in which money has been freezed/put on hold, the trial courts insist for registration of FIRs in these matters, which causes a lot of delay in release of money to cyber crime victims.

Therefore, I have been directed to request you to not to insist for registration of FIRs in the matters/complaints, which have already been registered on the National Cyber Crime Reporting Portal (NCRP)(<u>www.cybercrime.gov.in</u>), against the cyber frauds and such matters be disposed of by releasing the funds in favour of the victims, on the basis of the copy of complaint, lodged on the said portal, along with action taken report in the matter, to be filed by the respective Cyber Police Stations.

These instructions be followed in letter and spirit.
